ACCESSIBILITY

Why are we doing it?

Birmingham 2022 is the Games for Everyone, and this means we want everyone to be able to experience and enjoy the Games as equals. We are committed to hosting a safe, independent and dignified experience for anyone involved in the Games, be it athletes, spectators, or media: our aim is to create access to sport for all. This means delivering accessible venues, facilities, and barrier-free environments so that these once in a lifetime Games for Birmingham can be an exciting experience for everyone.

Our pledge to you:

- We are working to deliver the best accessibilty standards accross the Games, bettering best practice wherever possible
- Accessibility is a key consideration of all planning and has been embedded for all our venues from the outset of our work
- We have an ambition to reduce the disability employment gap. The Games is a Disability Confident Employer and continues to review its processes to remove barriers for paid roles and volunteering opportunities to make them accessible to all
- We will deliver the largest fully integrated para-sport programme of any Commonwealth Games, creating one Games for all athletes
- Considerations for accessible routes and services are embedded within our Games transport plans
- Accessible services will be uplifted and additional facilities will be available as required

EQUALITY, DIVERSITY AND INCLUSION (EDI)

Why are we doing it?

We want to be sure that the Games are accessible and inclusive to all. This is a vibrant and diverse region and the Games needs to reflect this. It provides the perfect opportunity for all people to learn more about each other and develop a shared understanding on issues of inequality. Birmingham 2022 will encourage and enable these conversations and provide an exceptional opportunity for cultural and commercial exchange among Commonwealth countries and act as a catalyst for shared experiences across arts, culture, and meaningful business engagement.

Our pledge to you:

- · We are engaging with as many groups as possible to ensure this is an event for everyone, working hard to connect local communities to the Games
- We have a dedicated team that will be present on the ground serving communities
- We have have been awarded the Leaders in Diversity Accreditation by The National Centre For Diversity
- We will assemble a workforce (employees and volunteers) representative of the West Midlands
- We will provide free access to 95% of the Games' cultural programmes
- We will host the first Commonwealth Games with more female medal events than male medal events
- We will have an accessible ticketing policy to maximise participation across the local community

JOB CREATION AND SOCIAL VALUE

Why are we doing it?

Through the benefits and opportunities that the Games provides, we aim to reduce unemployment and upskill the workforce in the West Midlands. This will help our region to recover from the economic impact of the pandemic, as well as helping to reduce poverty and exclusion. By creating new opportunities for individuals, we will also improve health and wellbeing.

Our pledge to you:

- We are working in partnership with the West Midlands Combined Authority and Commonwealth Sport Foundation to establish a Commonwealth Jobs and Skills Academy, which will support thousands of local people gain skills and experience through access to Games-time roles
- We are creating apprenticeships with our first two cohorts already employed to work on the Games
- We are creating 1,200 Organising Committee iobs
- We will build a community of circa 13.000 volunteers
- We will ensure delivering social value is a key requirement for contracts awarded
- We are measuring social value for the first time in Games history, setting a benchmark for future events and organisations

HUMAN RIGHTS

Why are we doing it?

Sport drives positive social progress, acting as a catalyst to bring significant change to people's lives. Unlocking human potential to help transform society means that Human Rights must be established as a core value of the Games. This approach permeates the entire Games operation and will be reflected in all areas of the Games, as a celebration of the diversity of the Commonwealth family.

Our pledge to you:

- · We are intrinsically aligning our approach with Commonwealth Games and UN best practice
- · We are ensuring that protection of human rights is not just written in policy but supported by comprehensive training in areas such as ethical trading, safeguarding and freedom of speech
- We require all contractors to demonstrate that they comply with anti-slavery and human trafficking laws

CARBONAND **AIR QUALITY**

Why are we doing it?

Climate change poses an existential threat to humanity and we must all act to mitigate our impact. We will build on the foundations of previous events of this scale to raise the bar on what can be achieved. Poor air quality is known to have a detrimental impact on health, and we believe that by working together we can make a difference. Our ambitions are aligned to the commitments of the UK, regional and local government ambitions on moving to net zero and delivering cleaner air.

Our pledge to you:

- Create a carbon neutral legacy for the Games*
- Wherever possible we will reduce carbon, and where that cannot be reduced, we will be offsetting this through credible and predominantly local carbon offsetting programmes, including forestation and tree planting, more of which is detailed within this plan
- We are organising carbon-neutral international travel and accommodation for the Queen's Baton Relay
- We are promoting low emission travel options and active travel such as cycling or walking

CIRCULAR ECONOMY PRINCIPLES TO MINIMISE WASTE

Why are we doing it?

Traditional approaches to product creation and disposal deplete natural resources and create unsustainable amounts of waste. The circular economy is about designing waste out of the system by keeping products and materials in use. By reusing and recycling products, our ambition is to achieve zero waste to landfill and conserve resources for future generations.

Our pledge to you:

- · We will aim to dramatically reduce the use of single use plastic by...
- Working with subcontractors and suppliers such as packaging and transport to minimise single use plastics across the full Games footprint
- Installing free drinking water refill points wherever possible
- Implementing waste reduction processes across all operations
- We will hire rather than buy equipment where possible
- We will plan for the end of the Games to ensure assets can be repurposed and reused in the future

CONSERVATION

Why are we doing it?

We are committed to doing what we can to conserve and enhance the natural environment for future generations. This means ensuring the conservation of our canals, rivers, and green spaces as part of our vital ecosystems. Beyond ecology, we are also looking to the Games to conserve and reinforce our cultural heritage, one of the most special attributes of the West Midlands.

Our pledge to you:

- · We are working with the main contractors of the new Sandwell Aquatics Centre and Alexander Stadium developments, to increase the levels of biodiversity and bring improvements to the local environment
- Clearing 22 miles of canals through the 'United by 2022' partnership with the Canals & Rivers Trust
- We are making conservation and sustainability part of the Games' regional and international education programmes
- Creation of 2.022 acres of forest through our partnership with Severn Trent.





DELIVERY

Our entire organisation is committed to the collective delivery of this plan. Our Board and Executive Management Team are providing accountability to the work, visible leadership, and measurement to ensure our vision to deliver 'The most Sustainable Commonwealth Games yet'.

To make this vision a reality, we are focussing on four operational areas.



PARTNER SPOTLIGHT

The Games has inspired collaborations and partnerships that will deliver long-term benefits to our environment and our communities. One such partnership is with our nature and carbon-neutral supporter, Severn Trent, which has an ambitious vision to deliver a carbon neutral legacy for generations to come throughout the West Midlands.



CREATING A CARBON NEUTRAL LEGACY

Severn Trent will deliver a series of initiatives that will leave a positive social and environmental legacy of sustainability. Severn Trent's plans are all about making a positive impact on the communities and the environment in the region they operate and to the lives of everyone they serve. More specifically, their environment work is about improving and enhancing the biodiversity of the region and providing a 'green hug' around existing urban areas by following watercourses and providing nature corridors across and through the area.

Two of the standout initiatives include the creation of 2,022 acres of Commonwealth Forest, as well as 72 tennis-court-sized mini forests, to be built in urban areas across the West Midlands.

The Commonwealth Forest, also in the West Midlands, will feature native species and will not only help local communities reconnect with nature, but it will also help offset the carbon generated by the Games.

Importantly, the forest will be accessible to everyone - by cycling, walking and public transport. It will be a place for people to experience nature and be together away from everyday life distractions.



SEVERN TRENT

Severn Trent also aims to create 72 mini urban forests, each around the size of a tennis court in urban areas across the West Midlands. Working with local partners, they will find the right type and size of land in places to create beautiful green spaces that will make a real difference to the local environment and the people who live there

Each forest would be linked to one of the nations or territories competing in the Games with the aim that their creation will be well underway for the baton relay to visit each forest location.

Each of these 'mini forests' will be planted with home-grown native species, creating new habitats for wildlife and caring for our natural water sources. The plan is to link each forest to schools and community groups and find ways for us all to feel involved with and enjoy our new green spaces.

Together these two initiatives will bring a range of benefits for generations to come.

- · Boosting urban biodiversity
- Connecting communities with accessible nature
- Supporting health and wellbeing
- Improving air quality and offsetting residual carbon

In addition, Severn Trent is looking to make tap water the first choice for the Games by providing water bars to provide free tap water to all attendees. Embedding refill behaviours is important to promote the value of water and encourage future generations to use water wisely.

There is a shared vision between Birmingham 2022 and Severn Trent. This is based on a dedicated approach to build on existing standards and work to create something new, and make a legacy of social and environmental change, and a carbon neutral future for generations to come.
